## Reaching Out by Reaching In

In the previous newsletter, Chaplain Dulakis wrote concerning inmates Melanie and Brittany. We would like to share how these two have really drawn us into their lives and exploded the prison ministry in which we had already been involved. We had been sending PMA lessons to detainees who requested them, receiving the completed lessons back, commenting on them, and returning them with the next lesson, often with a note of encouragement.

Pastor Dulakis shared with us about Melanie, requesting prayer for her along with Bible lessons. The notes she added to her returned lessons touched our hearts. The attitude of this sixteen-year-old girl, incarcerated, not knowing what she faced, and yet being so upbeat and positive, could only be coming from the Spirit within. She would regularly give us names of others who would like to do the lessons. Among these was Brittany. I can't remember when I have seen such a dramatic change in a

person's life as Christ had made in her life. Admittedly we did not know her before but since we have become very close to her she has shared very openly with us about her previous life. She really has nothing to go back to in her former life, and says that we and the Dulakises are her family now.

These two had witnessed to virtually every one in the women's dorm in our detention center and many of them have been taking the lessons. Both girls have completed all of the PMA studies, and Brittany has requested to do them again. Each of the girls have become missionaries, telling others about their Savior and suggesting that they too take the studies. Brittany has been instrumental in involving some 30 others to study the Bible

# Shelton Revival 2005

July 15-16, 2005

Prison Mission Association sponsors a large mass evangelistic event each year at the Washington Correction Center. This year's revival was held on July 15-16.

We praise the Lord for another successful event. Nearly 100 volunteers worked together to present the gospel to over 1500 inmates. Nearly 300 indicated they had made a decision to accept Christ or recommit their lives to Him. Each inmate to attend one of the events was given literature and an Introductory Bible study as well as the opportunity to sign up to enroll in our complete set of lessons.

Once again the Freedom Team strength and power team put on a fantastic program as they challenged the inmates with their demonstrations of feats of strength and tied it into the power of God. Their dramatic presentation along with inspirational testimonies of how God changed the lives of the team members provided an atmosphere that allowed the Holy Spirit to convict the hearts of many of the individuals that attended.

For the first time the revival was joined by the band Echoes of Creation. Several members of the band are from Grace Bible Church in Port Orchard, WA. They performed three shows for nearly 400 inmates.

Among the other groups that joined to make the revival a success was the New Life Prison Ministry from Edmond Washington. They assisted as counselors, performed music and gave testimonies and a message on Saturday afternoon. Also joining the group was the Grace Bible Church softball team which played two games against the prison team and the Thurston County Jail ministry team that helped as counselors for some of the concert performances.

We had hoped to be able to have two days of follow-up on the next Monday and Tuesday. As it turned out the facility was not able to make the arrangements to allow access to the inmates on those days. However, the chaplain suggested that next year the PMA team could take over the regular Sunday morning chapel schedule and use the time for personal follow-up for the inmates.

We wish to thank all that prayed for, participated in and donated to the revival. Next year the dates are July 14-15, 2006

# GOD'S PERSPECTIVE

This is the ninth in a series that examines references to prisons and prisoners in the Bible. In this article we will reflect on the brief but important period during which the Lord Jesus Christ was a prisoner at the hands of the Roman Empire. We can read about the Lord's time as a prisoner in the last chapters of the four Gospel records.

More than any other person in history the Lord Jesus was unjustly accused, arrested, incarcerated and executed. He was willing to endure all those injustices which were committed against him in order to fulfill the will of God.

First, Jesus' arrest and imprisonment was the result of betrayal by one that seemed to be a friend. Such a situation is not uncommon as many prisoners today are incarcerated because their friends were willing to testify against them in exchange for a lesser sentence. In the case of Judas, it seems he was just looking for money (Matthew 16:15).

His arrest would have gone peacefully since Jesus was already waiting and expecting the men sent from the high priest to come and get him. However, an overzealous Peter reacted to the situation attacking one of the guards that came to arrest Jesus, grabbed a sword and cut off the guard's ear. Despite all that was happening to him, Jesus turned his attention to the injured guard, the same one that was coming to commit a tremendous injustice against him, and he reattached the ear. This demonstration of compassion showed how the Lord was able to look beyond his personal circumstances and see the needs of others, even those meant to do him harm.

At his trial the Lord, al-

though entirely innocent, did not fight or protest his conviction. Not to imply that an innocent person should allow himself to be railroaded by a corrupt system, but rather it shows that our Savior had a bigger picture in view than his own personal circumstances. He was willing to allow such terrible injustice to be inflicted on him because he knew that his obedience was part of a much greater plan that the Father had for him and mankind. This "bigger than the moment" perspective is described for us in Hebrews 12:2, "Looking unto Jesus the author and finisher of our faith; who for the joy that was set before him endured the cross, despising the shame, and is set down at the right hand of the throne of God."

Jesus actually spent very little time as a prisoner, less than 24 hours. Yet during that time he received more abuse and humiliation than many inmates that have spent years incarcerated. Much of what happened to him during that time was in order to fulfill direct prophecies about him. The short time that Jesus was in prison was in keeping with the traditional use of jails in the ancient world. Jails were not used for punishment per se, but rather as simply a place to hold an accused individual until he could be tried and punished in a way commensurate with his crime which was either to pay restitution or to be executed.

In the end we see the Lord Jesus Christ as a shining example of how one can endure difficulty and hardship in order to bring glory and honor to God. Jesus was tempted "in every way," yet he never wavered in his commitment to do his Father's will.

## THE SPANISH SIDE

### SELFOR'S UPDATE

In one of our regular English classes for the Spanish prisoners, a sharp middle-aged American man entered and asked if he too could study the Bible with the men, in addition to learning Spanish. If he was to spend days and days in the "pod" with the Latin men, why not be able to speak to them? So, here we had Tony with the PMA lessons in English, along with our Spanish guys doing the EBB lessons, all in one room. We soon learned that Tony is a very gifted man. He had come to Christ as a child, walked away from the Lord during his teen years, and then came back to Christ later in life. Through a false accusation, he was in prison, unable to make the bail. Thirteen months Tony was in jail, but GOD had a purpose for him, to help him get back into relationship with Himself. What a privilege it was to work with Tony, and see him grow again.

Tony was instrumental in bringing out other English speaking men to study the Word, and before we knew it, we were getting together on Saturday mornings studying these precious lessons in English. But as the group began to grow, we needed others to help. What a wonderful opportunity to get some men from Grace Bible Fellowship, Pinellas Park, FL, to get involved. Now, along with three others, we spend some precious hours with these men. Praise God for Tony!

Suddenly one day, Tony did not appear for the classes. Where was he? The others never know, for suddenly they come and

## An Inmate's Reflection

*An inmate in Indiana originally charged with murder whose charges were later dropped because of a lack of evidence reflects on jail and incarceration.*

I believe deeply in individuality and its crucial importance to humanity. Jail is supposed rehabilitation, yet it deprives one of the freedom that makes them who they are. For a majority of inmates, drugs and alcohol are all that the prisoner is being deprived of, in which case jail has its benefit to society. Jail robs you personally of your individuality. Your ability to laugh, to cry, to express emotion, to love is slowly but surely taken away little by little, day by day. I'm not saying that some do not deserve sanctions, nevertheless I am questioning our approach. Most people incarcerated are already suffering from problems due to troubled childhoods, poor families, which led to self image problems that stem from insecurities. They are already lacking a major ingredient that incarceration does not provide...love. Without this, all jail tends to create are cold-hearted, self righteous animals with no hearts, with no emotions. Jail teaches you're not permitted to show emotion, unless it is anger or bitterness usually within their own hearts yet aimed at innocent targets. This type of anger and bitterness is horrible, it is not at all rehabilitating! Some lessons learned in jail include: "to each his own," "watch your back," "trust no one," "only the strong survive." Is that rehabilitative?

Jail in rare cases is rehabilitative, from my experience thus far. For the most part it seems to be an emotion stealing, love stealing, heart hardener which leaves many people worse off than when they arrived. Solutions are many yet few are adopted or even thought of. Love is the answer that only God can provide. An intimate relationship with the Creator is truly the only rehabilitating everyone needs. Only God can rehabilitate the heart and unless that fact is realized, jail is a cold and heartless place to be, full of people whom jail will never rehabilitate.

## KAREN'S KORNER

The office of PMA in Port Orchard continues to hum with busyness. The average person may think we JUST send lessons. More than just Bible lessons, however, are mailed from our office. Our mailings go out in two forms: regular mail and automated mail. Our regular mail contains the corrected lessons and lightweight literature. The literature for regular mailings include half size inserts like *Focus on the Family*, *Power for Living*, *Insights for Living*, *Have a Great Day*, etc. The contents do not exceed 1.9 oz and postage costs 60 cents each. Automated mail allows us to send heavier literature items such as *Our Daily Bread*, *The Berean Searchlight*, *Discovery Series* booklets, etc. Automated mail allows us to fill an envelope with a new lesson and literature up to 3.2 oz for 19 cents each. A big THANK YOU for all those that keep us well supplied with all of this literature.

On various days of the week we have volunteers that come into the office to help with different important tasks. Every other Monday Linda Howell comes in and sends out the children's lessons. She also sends out requests to the people that pray for our inmates. They also faithfully pray for all of our new students that have enrolled in the correspondence lessons. Believe it or not there is a lot of detail she needs to tend to before she sends out the prayer requests. We black out the inmates' address and personal I.D. information. We have to maintain everyone's privacy.

On Tuesdays and Thursdays Celeste Wedding comes to the office and fills envelopes with new lessons and fills the correctors' folders which they pick up weekly to get new lessons. On Wednesdays Karen Gillis helps me with the donation deposits, and any odds and ends I need help with. Louise Hunsaker also comes in and corrects lessons. Gladys Hanson folds new lessons for the bins on

Sunday morning at 8:30 as we were preparing to go to church, the phone rang and it was Tony. He was "out" and anxious to see us. He didn't have a car, a job, any clothes, or money, or he would have come to church. So, the following day, with my wife Sally, we drove the almost 2 hours to find Tony at a friends house, way out in the country. What a joy to see him again. We had lunch together and talked over his priorities and possibilities. God is good. We ask you to pray for Tony, that he would make good decisions, and would soon have a job. Pray with us for his walk with the Lord and his desire to bring others to Christ.

using PMA lessons. Often the new women are so eager to get started, and Brittany is so eager to help, she has been known to hand copy a lesson. Another time she erased all of the penciled answers from one of her previous lessons. Once she had two girls do a lesson, each doing half. They then each requested their own.

We had talked a number of times about requesting a visit with our two girls but that didn't happen until they were each moved. They are now about 150 miles from us but only about 30 miles from each other. We have made several trips to visit them face-to-face. Though separated by a glass partition, we have sweet fellowship and precious times of prayer together. The following is excerpted from a letter Brittany wrote shortly after one of our visits. "Wow! What a wonderful day! My family came to see me. I'm so thankful I'm here. Yes I am. Life is so wonderful. I'm grateful and thankful to God today."

All in all God has immeasurably blessed Bev and me since we became involved in this exciting ministry. To God be the glory for the things He has done.
